

Kalpataru

By the authority vested in me as The Supreme Pontiff of Hinduism and the Head of State of KAILASA, The Living Representative of Paramashiva, by the Constitution and the laws of Sanatana Hindu Dharma as ordained by Paramashiva in Vedas and Agamas, it is hereby ordered as follows:

Sec. 1. Implementing Measures and policies. My administration and KAILASA is committed to spreading the science of manifesting reality - Kalpataru, to all the Hindus around the world. The Federal Government of Kailasa is responsible for spreading the sacred knowledge of manifesting reality through the 4 tattvas (life principles) as revealed by Paramashiva: Integrity, Authenticity, Responsibility and Enriching. For the last 26 years, the Federal Government of Kailasa has been leading myriad humanitarian services globally. KAILASA shall continue working towards expanding the impact of each and every individual's divine consciousness and make them experience their higher identity by means of offering selfless humanitarian services through KAILASA's humanitarian agencies.

The Kalpataru is a powerful workshop that aligns one's actions to their true intentions, awakening the innate power to manifest the reality as desired. The Sovereign Order of Kailasa has an obligation to build an integrated network of support system capable of providing effective Hindu techniques such as the science of Kalpataru for all Hindus and make it available for the rest of humanity. I am therefore issuing a global call to action for all Hindus to:

- (a) All seventeen nations of KAILASA - all Samrajyams (kingdoms), Samasthanas (spiritual kingdoms), all their branches, all the 1,500 de facto embassies of KAILASA and sixty-four Sovereign Orders of Kailasa shall organise daily in-person and digital Kalpataru workshops
- (b) Develop a training module to equip the acharyas (teachers and moderators) by equipping them with the tools to cater to a wide range of Hindus
- (c) Providing access to Nithyananda Hindu University to all citizens of e-Kailasa for all to complete courses on the science of Kalpataru
- (d) Empowering people to enhance their well-being and consciousness by participating in Kalpataru workshop.
- (e) Enhance digital innovation to provide access to Hindus to the complete science of Manifesting Reality: Kalpataru.

Sec. 3. Establishment of a KAILASA's Manifesting Reality: Kalpataru Working Group. The KAILASA's Science of Manifesting Reality: Kalpataru Working Group is hereby

established to facilitate the science of manifesting reality to Hindus. The Working Group will be chaired by the Secretary of Department of Human Services, or his designee. The Working Group shall be composed of representatives from the Department of Ministry of Sovereign, the Department of Enlightened Civilization, the Department of Information Broadcasting, the Department of Education, the Department of Global Communications, the Office of Management and Budget (OMB), and such representatives of other executive departments, agencies, and offices as the Co-Chairs may, from time to time, designate with the concurrence of the head of the department, agency, or office concerned. All members of the Working Group shall be full-time, or permanent part-time, officers or subjects of the Federal Government of Kailasa.

Sec. 4. Responsibilities of KAILASA's Manifesting Reality: Kalpataru Working Group. Within 24 hours of the date of this order, the Working Group shall develop and submit to the Supreme Pontiff a report that outlines a plan for service coordination between all relevant stakeholders and executive departments and agencies (agencies) to provide Hindus with the access to the receive the knowledge of manifesting reality: kalpataru. This Working Group shall be responsible to collect and compile reports from all Samrajyams (kingdoms), Sarvajnapeetams (spiritual kingdoms) and de facto embassies of Kailasa with complete statistics of the total number of people benefitting through these workshops.

Sec. 5. General Provisions.

- a. Nothing in this order shall be construed to impair or otherwise affect:
 - i. the authority granted by law to an executive department or agency, or the head thereof; or
 - ii. the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.
- b. This order shall be implemented consistent with applicable law and subject to the availability of appropriations.

This order is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Kailasa, its departments, agencies, or entities, its officers, volunteers, or any other person, or against any nation's integrity or laws.
